Under the Proposed Settlement, the parties have agreed to establish 15 a Settlement Fund in the amount of \$275,000.00, which will be funded solely by Top Flite. Top 16 Flite does not have the financial ability to contribute additional funds beyond those it is already 17 contributing to settlement without jeopardizing its business operations. A potential 18 liability/judgment of \$42,500,000 would be financial ruinous to Top Flite.


